

1 FIFTH AMENDMENT TO PERMIT NO. 28246

3 THIS FIFTH AMENDMENT TO PERMIT NO. 28246 is made and entered, in
4 duplicate, by and between the PARKS AND RECREATION COMMISSION OF THE CITY
5 OF LONG BEACH, CALIFORNIA, at its meeting on December 8, 2011, through the
6 Director of the Department of Parks, Recreation and Marine ("Director") of the City of Long
7 Beach ("City"), and CATHY JACOBSON-GUZY DOING BUSINESS AS FIRST SERVE
8 TENNIS, INC., a California corporation ("Permittee").

9 WHEREAS, the Parties executed Permit No. 28246 wherein Permittee
10 agreed to operate and maintain the Tennis Pro Shops, Instructional Service and Court
11 Rental system at Billie Jean King and El Dorado Tennis Centers and to manage Tennis
12 Instruction through the Parks, Recreation and Marine schedule of contract classes; and

13 WHEREAS, the parties desire to amend this Permit by extending the term;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in
15 Permit No. 28246, the parties agree as follows:

16 1. Section 2 of Permit No. 28246 is hereby amended in its entirety to
17 read as follows:

18 "2. Term. The term of this Permit shall commence at midnight on January
19 1, 2012 and shall terminate at 11:59 p.m. December 31, 2018, unless revoked prior to said
20 expiration date as provided herein."

21 2. Except as expressly stated herein, all of the terms, covenants, and
22 conditions of Permit No. 28246 are ratified and confirmed and shall remain in full force and
23 effect.
