WHEREAS, the parties entered Subcontract No. 30899 whereby Organization agreed to provide these services to the City; and

WHEREAS, the parties desire to extend the term of this Subcontract;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Subcontract No. 30899 and herein, the parties agree as follows:

1. Section 3 of Subcontract No. 30899 is amended in its entirety to read as follows:

"Section 3. The term of this Subcontract shall commence at midnight on July 21, 2008 and, unless sooner terminated as provided herein, shall terminate at 11:59 p.m. July 20, 2011."
