3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH ESTABLISHING FEES FOR  
5 CUSTOMER REQUESTED METER READS

7 WHEREAS, prior to adoption of this Resolution revising the schedule of  
8 fees, public notice and hearing have been given in accordance with Section 66018 of  
9 the California Government Code;

11 NOW, THEREFORE, the City Council of the City of Long Beach resolves  
12 as follows:

13 Section 1. That the City Council of the City of Long Beach hereby  
14 establishes the fees set forth on Exhibit "A", attached hereto and incorporated herein by  
15 this reference, for the services rendered by the Long Beach Department of Financial  
16 Management.

17 Sec. 2. The purpose of the fees herein imposed is to recover for the City  
18 its costs of administering and providing the service for which the fee is levied. Such fee  
19 or fees do not exceed the reasonable cost of providing services necessary to the  
20 activity for which the fee is charged and is not levied for unrelated revenue purposes.

21 Sec. 3. Constitutionality, Severability. If any section, subsection,  
22 sentence, clause or phrase of this Resolution is for any reason held to be invalid or  
23 unconstitutional by the decision of any court of competent jurisdiction, such decision  
24 shall not affect the validity of the remaining portions of the Resolution. The City Council  
25 hereby declares that it would have passed this Resolution and each section, sub-  
26 section, sentence, clause and phrase hereof, irrespective of the fact that any one or  
27 more of the sections, sub-sections, sentences, clauses or phrases hereof be declared  
28 invalid or unconstitutional.


