

RESOLUTION NO. RES-10-0074

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DIRECTING THE LOS ANGELES COUNTY AUDITOR-CONTROLLER TO INCLUDE ON THE 2010-2011 SECURED TAX ROLL CERTAIN ASSESSMENTS MADE PURSUANT TO PROVISIONS OF THE LONG BEACH MUNICIPAL CODE FOR WEED ABATEMENT, DEBRIS REMOVAL AND/OR LOT CLEANING CHARGES

WHEREAS, Chapter 8.56 of the Long Beach Municipal Code provides a system for levy and collection to cover the cost of removing weeds and debris by the City from privately owned real property; and

WHEREAS, the City's Building Official is required to certify to the City Treasurer-Tax Collector the amount of the unpaid weed and debris removal and lot cleaning charges and interest for delinquency; and

WHEREAS, the City's Building Official has certified to the City Treasurer-Tax Collector unpaid lot cleaning charges and interest for delinquency which should be entered upon the secured tax roll and collected in the same manner as ad valorem taxes.

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The Los Angeles County Auditor-Controller is hereby authorized and requested to include on the 2010-2011 secured tax roll the delinquent assessment charges, and penalties, if any, for each of the described parcels of real property set forth in Exhibit "A" attached hereto and made a part hereof. 1 parcel number and the total unpaid assessment, together with interest thereon, and the
2 situs address of the real property are set forth in Exhibit "A". Only the amount set forth
3 in the third column entitled "Amount" should be entered as charges due the City of Long
4 Beach on the real property to which the amount refers. The Los Angeles County
5 Auditor-Controller is directed to collect said charges in the same manner as ad valorem
6 taxes.

7 Section 2. The Director of Financial Management is directed to transmit
8 to the County Auditor-Controller a certified copy thereof on or before July 31, 2010.

9 Section 3. This resolution shall take effect immediately upon its
10 adoption by the City Council, and the City Clerk shall certify the vote adopting this
11 resolution.



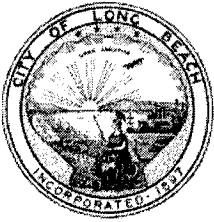
