A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE UP TO THIRTY DIESEL PARTICULATE TRAP FILTER RETROFIT KITS THROUGH THE CONTRACT BETWEEN THE CITY OF RIVERSIDE AND VALLEY DETROIT DIESEL ALLISON, INC. NOW KNOWN AS VALLEY POWER SYSTEMS, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

Detroit Diesel Allison, Inc) to purchase up to thirty (30) diesel particulate trap filter retrofit kits of substantially the same type and kind purchased by the City of Riverside pursuant to the Riverside Contract except as modified by mutual agreement of the City of Long Beach and Valley Power Systems, Inc. and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the City of Riverside in an amount not to exceed \$227,733.00 plus tax, for a period extending through December 31, 2005 with an option to extend for an additional year.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
