This Agreement may be terminated by either party upon thirty (30) days written notice without penalty or further obligation after City has paid for services rendered through the date of termination."
- 2. Except as set forth in this Sixth Amendment, all terms and conditions of Agreement No. 30332 are ratified and confirmed and shall remain in full force and effect.
