2 WHEREAS, on June 8, 2021, City Council approved extending the
3 Agreement one (1) additional one-year period; and

4 WHEREAS, the Parties entered into a Seventh Amendment to increase the
5 authority amount for a total not to exceed Two Million One Hundred Sixty-Nine Thousand
6 Eight Hundred Sixteen Dollars and Nineteen Cents (\$2,169,816.19), and extend the term
7 of the Agreement to July 19, 2022; and

8 WHEREAS, on July 5, 2022, City Council approved extending the Agreement
9 by one (1) additional one-year period; and

10 WHEREAS, the Parties entered into an Eighth Amendment to increase the
11 Agreement authority amount for a total not to exceed amount of Four Million One Hundred
12 Sixty-Nine Thousand Eight Hundred Sixteen Dollars and Nineteen Cents (\$4,169,816.19),
13 extend the term to July 19, 2023, update the City Representative, and attach an updated
14 rate sheet; and

15 WHEREAS, on June 6, 2023, City Council approved to extend the term of
16 the Agreement by one (1) additional one-year period; and

17 WHEREAS, the Parties desire to extend the term of the Agreement using the
18 authorized one-year period;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions herein contained, the Parties agree as follows:

21 1. Section 2 of the Agreement is hereby amended to read as follows:

22 "2. TERM. The term of this Agreement shall commence at midnight on
23 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2024, unless sooner terminated
24 as provided in this Agreement, or unless the services or the Project is completed sooner."

25 2. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33913 are ratified and confirmed and shall remain in full force
27 and effect.
