3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH ORDERING, PROCLAIMING,
5 CALLING, GIVING NOTICE OF AND PROVIDING FOR THE
6 HOLDING OF A PRIMARY NOMINATING ELECTION TO BE
7 HELD IN THE CITY OF LONG BEACH ON TUESDAY, THE
8 8TH DAY OF APRIL, 2008, FOR THE ELECTION OF
9 GOVERNING BOARD MEMBER OF THE LONG BEACH
10 UNIFIED SCHOOL DISTRICT AREAS 2 AND 4 FOR A FULL
11 TERM OF FOUR (4) YEARS COMMENCING WITH THE
12 THIRD MONDAY OF JULY, 2008; DESIGNATING THE
13 BALLOT LISTING OF THE CANDIDATES TO BE VOTED
14 ON; AND ADOPTING PROVISIONS RELATING TO THE
15 TRANSLATIONS OF AND THE CHARGES FOR COSTS OF
16 CANDIDATE STATEMENTS

18 WHEREAS, the City Council of the City of Long Beach, by Resolution No.
19 RES-07-0158, duly called and provided for the holding of a Primary Nominating Election
20 on Tuesday, April 8, 2008; and

21 WHEREAS, in accordance with applicable law, it is necessary for the City
22 Council to order, proclaim and call a Primary Nominating Election for the election of Long
23 Beach Unified School District Board Member Areas 2 and 4;

25 NOW, THEREFORE, the City Council of the City of Long Beach does
26 resolve, order, proclaim, declare, call and give notice as follows:

27 Section 1. Pursuant to the provisions of the Constitution and laws of the
28 State of California and the provisions of the Charter of the City of Long Beach governing

1 the holding of municipal elections, a Primary Nominating Election is ordered, proclaimed
2 and called to be held in the City of Long Beach, California, between the hours of 7:00
3 a.m. and 8:00 p.m. on the 8th day of April, 2008, for the purpose of electing members of
4 the Long Beach Unified School District Governing Board Member Areas 2 and 4, for a full
5 term of four (4) years, commencing with the third Monday of July, 2008.

6 Section 2. The following list of candidates which has been regularly
7 certified by the City Clerk sets forth the candidates nominated as required by law for the
8 offices of Long Beach Unified School District Governing Board Member Areas 2 and 4,
9 and is in the order of the randomized alphabet selected by the Secretary of State:

14 LONG BEACH UNIFIED SCHOOL DISTRICT

19 Section 3. Notice is given of the holding and of the time and place of the
20 election.

21 Section 4. The polls for the Primary Nominating Election shall be open at
22 7:00 a.m. and shall be kept open until 8:00 p.m. when the polls shall be closed; except
23 that, if at the hour of closing there are any voters in the polling place or in line at the door
24 who are qualified to vote, and who have not been able to do so since appearing, the polls
25 shall be kept open a sufficient time to enable them to vote; but no one who arrives at the
26 polling place after 8:00 p.m. shall be entitled to vote, although the polls may be open
27 when such person arrives.

28 Section 5. California Elections Code Section 13307 requires that a
candidate's statement must be translated in Spanish at the candidate's request. Further,

1 in accordance with the requirements of the federal Voting Rights Act of 1965 (PL 94-73)
2 all candidates' statements shall be translated into the languages indicated as follows:
3 Khmer, Spanish, Tagalog and Vietnamese. Any translations into the required languages
4 shall be available in the City Clerk's office upon request. A candidate shall not be
5 required to pay for the cost of translating his or her candidate's statement into any foreign
6 language required pursuant to federal and/or state law. However, a candidate shall be
7 required to pay to the cost of printing the candidate's statement in the sample ballot
8 pamphlet in a foreign language.

9 Section 6. Pursuant to Section 13307 of the California Elections Code, a
10 charge shall be levied against each candidate for the costs of the candidate's statements
11 sent to each voter. The City Clerk is directed and authorized to establish and implement
12 the charge for the costs of printing, handling, translating, and mailing any candidate
13 statements as provided in Elections Code Section 13307. Any allegation of indigency or
14 inability to pay the requisite fee in advance shall be handled by the City Clerk in
15 accordance with the provisions of Elections Code Section 13309, and in such instances
16 the candidate's statement shall only be published in the English language.

17 Section 7. No candidate will be permitted to include any additional
18 materials in any sample ballot package.

19 Section 8. The City Clerk shall provide each candidate or the candidate's
20 representative with a copy of this resolution.

21 Section 9. This resolution shall take effect immediately upon its adoption
22 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

23 I hereby certify that the foregoing resolution was adopted by the City
