The City of Long Beach thanks you for taking this request into consideration. Enclosed is a copy of the City Council documentation for your file.

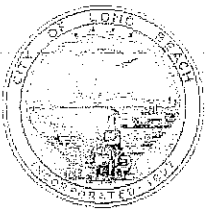

I am submitting the following conditions for your consideration for an original application of an On-Sale Beer and Wine boat license.

1. There shall be no sales of alcoholic beverages while the boat is at any dock, except sales to passengers one-half hour prior to departing on scheduled trips or charters, and one-half hour after returning to designated commercial docks pursuant to (A) or (B).
 - A. In addition to its primary home port dock, a licensee may designate up to ten (10) commercial docks each year at which it intends to embark or debark passengers.
 - B. A licensee may designate any public commercial dock within the state. Such designation shall be in writing.
