RECOMMENDATION:

Authorize the City Manager to execute a Public Walkways Occupancy Permit for sidewalk dining at Hole Mole Restaurant located at 421 Obispo Avenue. (District 2)

DISCUSSION

Scott Bascon, owner of Hole Mole Restaurant located at 421 Obispo Avenue, requests a permit to temporarily occupy part of the adjoining sidewalk for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories to be placed in the permit area are shown on the attached Exhibit A. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code which describes temporary uses of public right-of-way. The width of the sidewalk is 12 feet. A minimum clearance of 5 feet will be maintained between the permit area and the curb.

This permit request was reviewed and approved by the Long Beach Fire Department on December 10, 2008. Deputy City Attorney Linda Trang prepared the subject permit on July 6, 2009.

This matter was reviewed by Deputy City Attorney Linda Trang on July 6, 2009 and by Budget and Performance Management Bureau Manager David Wodynski on September 15, 2009.


