4 THIS FIRST AMENDMENT to Contract No. 28322, by and between
5 KINETIC LABORATORIES, INC., a California corporation, ("Contractor") with its principal
6 place of business at 307 Washington Street, Santa Cruz, California 95060, and THE CITY
7 OF LONG BEACH, a municipal corporation ("City,") is made and entered, in duplicate, as
8 of April 19, 2006, for reference purposes only, pursuant to a minute order of the
9 City Council at its meeting held on February 7, 2006.

10 WHEREAS, the parties entered Contract No. 28322 for non-point source
11 water quality monitoring services ("the Work"); and

12 WHEREAS, the parties desire to extend the term of said Contract; and

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in
14 Contract No. 28322 and herein, the parties agree as follows:

15 1. The term of Contract No. 28322 shall be extended and shall expire on
16 September 30, 2006.

17 2. The total expenditures under Contract No. 28322, including this
18 amendment shall not exceed \$1,472,000. The City does not guarantee that the full
19 amount shall be expended; the City's expenditures are based on its needs and
20 requirements and the amount and nature of the services performed by Contractor.

21 3. Except as expressly amended herein, all of the terms and conditions in
22 Contract No. 28322 are ratified and confirmed and shall remain in full force and effect.

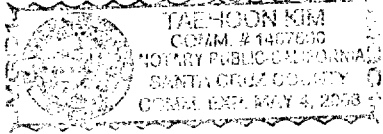
