7 WHEREAS, the State Department of Parks and Recreation has been
8 delegated the responsibility by the Legislature of the State of California for the
9 administration of the Statewide Park Program, setting up necessary procedures
10 governing the Application; and

11 WHEREAS, said procedures established by the State Department of
12 Parks and Recreation require the applicant to certify by resolution the approval of
13 application(s) before submission of said application(s) to the State; and

14 WHEREAS, the applicant will enter into a contract with the State of
15 California to complete the grant scope project;

16 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City
17 of Long Beach hereby:

18 Section 1. Approves the filing of an application for the Scherer Park
19 Community Center; and

20 Section 2. Certifies that said applicant has or will have available, prior to
21 commencement of any work on the project included in this application, the sufficient
22 funds to complete the project; and

23 Section 3. Certifies that the applicant has or will have sufficient funds to
24 operate and maintain the project(s); and

25 Section 4. Certifies that the applicant has reviewed, understands, and
26 agrees to the General Provisions contained in the contract shown in the Grant
27 Administration Guide; and

28 Section 5. Delegates the authority to City Manager to conduct all

1 negotiations, sign and submit all documents, including but not limited to applications,
2 agreements, amendments, and payment requests, which may be necessary for the
3 completion of the grant scope; and

4 Section 6. Agrees to comply with all applicable federal, state and local
5 laws, ordinances, rules, regulations and guidelines.


6 Section 7. This resolution shall take effect immediately upon its adoption
