Re: Records Retention and Archive Policies

## Honorable Members:

On Oct. 13, 2003 we sent the enclosed letter to the RDA board, Mayor, City Council and City Attorney asking that item #55 on the October 14, 2003 council agenda be removed due to our misgivings concerning the destruction of numerous Redevelopment, Community and Economic Development records. We were particularly concerned about the potential destruction of " *Redevelopment Project Files, 1988-1995,*" because the City Council had recently approved an impartial analysis of City redevelopment practices. Our requested was honored and the item was pulled from the agenda.

In the interim, we have been given the opportunity inspect the records and in so doing, we noted some records slated for destruction are not what was described in the council memorandum. As yet, we have seen no indication that the Redevelopment Agency Board approved or had an opportunity to review those records that are under their statutory control. Additionally, we noted the following:

- Although the document destruction memorandum described records dating from 1999 and prior years, we inspected documents dating as recently as 2002 and 2003.
- We inspected original documentation, including trust deeds, correspondence and other records pertaining to currently outstanding and/or litigated loans.
- We saw numerous, non-sensitive records of historical value, such as news clippings and economic reports (often funded with federal and/or state grant dollars), that we believe should serve as public information on file with the library and/or the City Clerk.
- We viewed numerous performance evaluations, critical memorandums, and historical files

related to economic and redevelopment policies that might serve as supporting documentation for any impartial analysis of Redevelopment, Economic and Community Development policies; spending practices and effectiveness.

In conclusion, we feel it would be timely to undertake a review of the city's records retention and archivial policies to ensure that both currently useful and historic data are available to decision-makers and the general public and to comply with federal and state guidelines. We are excited about your recent appointment of Larry Herrerra as City Clerk and about new possibilities afforded by electronic media storage, and we respectfully request that you refer these matters to Mr. Herrera's attention.

With respect to the specific referenced documents, Director of Economic Development Roger Haley has assigned Graham Brooks to oversee our inspection of the records. To conserve on staff time and photocopying costs; Mr. Haley approved our taking one copy where duplicate reports existed and provided a duplicate for the City Clerk per Mr. Haley's request. We also compiled a stack of news clips and a variety of economic and financial reports funded with federal and state grant dollars that might be considered an asset for public information on file in the Long Beach Public Library. Lastly; we provided documents for which we have requested copies and are waiting for feedback from the City Attorney's office. Upon his review and agreement, we would like to copy the records ourselves using our own equipment. Finally, we request that these documents not be destroyed until they have been inspected by whatever contractor the City selects to perform an impartial analysis of Redevelopment practices.
