

1 FIRST AMENDMENT TO AGREEMENT NO. 33504

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33504 is made and
4 entered, in duplicate, as of November 20, 2014, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 July 22, 2014, by and between RJM DESIGN GROUP, INC., a California corporation with
7 a place of business at 31591 Camino Capistrano, San Juan Capistrano, California 92675
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with as-needed landscape architectural services ("Project");
11 and

12 WHEREAS, the parties entered Agreement No. 33504 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to increase the Agreement amount by
15 \$750,000 for a total not to exceed amount of \$1,000,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 33504 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this reference,
23 in accordance with the standards of the profession, and City shall pay for these services
24 in the manner described below, not to exceed One Million (\$1,000,000), at the rates or
25 charges shown in Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 33504 are ratified and confirmed and shall remain in full
28 force and effect.
