

THIRD AMENDMENT TO AGREEMENT NO. 32391

THIS THIRD AMENDMENT TO AGREEMENT NO. 32391 is made and entered, in duplicate, as of March 14, 2016 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on March 8, 2016, by and between LINK2GOV CORP., a Tennessee corporation (a wholly-owned subsidiary of FIDELITY NATIONAL INFORMATION SERVICES, INC.) ("Consultant"), with a place of business at 113 Seaboard Lane, Suite A-250, Franklin, Tennessee 37067, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with credit card processing services; and

WHEREAS, the parties entered Agreement No. 32391 whereby Consultant agreed to provide such services; and

WHEREAS, the parties desire to extend the term and add \$276,000 for a total not to exceed amount of \$916,000;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Amendment, the parties agree as follows:

1. Section 2 of Agreement No. 32391 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on May 1, 2011, and shall terminate at 11:59 p.m. on October 30, 2017, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly amended in this Third Amendment, all terms and conditions in Agreement No. 32391 are ratified and confirmed and shall remain in full force and effect.
