THIS NINTH AMENDMENT TO AGREEMENT NO. 33917 is made and entered, in duplicate, as of February 16, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2022, by and between RANIA ALOMAR ARCHITECT, INC. dba RA-DA, a California corporation ("Consultant"), with a place of business at 7523 Norton Avenue, West Hollywood, California, 90046, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33917 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services in an amount not to exceed Four Hundred Thousand Dollars (\$400,000) for a period of two (2) years with the option to extend the term for three (3) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to increase the Agreement authority for a total not to exceed One Million Four Hundred Thousand Dollars (\$1,400,000), and extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to increase the authority amount for a total not to exceed One Million Nine Hundred Thousand Dollars (\$1,900,000); and

WHEREAS, the Parties entered into a Third Amendment to increase the authority amount for a total not to exceed Three Million Two Hundred Thousand Dollars (\$3,200,000), and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term to July 19, 2020; and

WHEREAS, on June 9, 2020, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fifth Amendment to extend the term

2 WHEREAS, on June 8, 2021, City Council approved extending the  
3 Agreement one (1) additional one-year period; and

4 WHEREAS, the Parties entered into a Sixth Amendment to increase the  
5 authority amount for a total not to exceed Three Million Five Hundred Thousand Dollars  
6 (\$3,500,000), and extend the term to July 19, 2022; and

7 WHEREAS, on July 5, 2022, City Council approved extending the  
8 Agreement one (1) additional one-year period; and

9 WHEREAS, the Parties entered into a Seventh Amendment to increase the  
10 authority amount for a total not to exceed Three Million Seven Hundred Fifty Thousand  
11 Dollars (\$3,750,000), extend the term to July 19, 2023, update the City Representative,  
12 and attach an updated rate sheet; and

13 WHEREAS, the Parties entered into an Eighth Amendment to increase the  
14 authority amount for a total not to exceed amount of Four Million Seven Hundred Fifty  
15 Thousand Dollars (\$4,750,000); and

16 WHEREAS, on June 6, 2023, City Council approved to extend the term of  
17 the Agreement by one (1) additional one-year period; and

18 WHEREAS, the Parties desire to extend the term of the Agreement using  
19 the authorized one-year period;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
21 conditions herein contained, the Parties agree as follows:

22 1. Section 2 of the Agreement is hereby amended to read as follows:

23 "2. TERM. The term of this Agreement shall commence at midnight on  
24 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2024, unless sooner  
25 terminated as provided in this Agreement, or unless the services or the Project is  
26 completed sooner."

27 2. Except as expressly modified herein, all of the terms and conditions  
28 contained in Agreement No. 33917 are ratified and confirmed and shall remain in full
