

THIRD AMENDMENT TO CONTRACT NO. 35321

THIS THIRD AMENDMENT TO CONTRACT NO. 35321 is made and entered into as of April 7, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 16, 2019, by and between LOS ANGELES TRUCK CENTERS, LLC, a California limited liability company ("Contractor"), with a place of business at 2429 S. Peck Road, Whittier, CA 90601, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City desires to purchase Sterling and Autocar heavy-duty truck parts ("Truck Parts"); and

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35321 (the "Contract") whereby Consultant agreed to provide these parts as described in Resolution No. RES-19-0106; and

WHEREAS, the Parties entered into a First Amendment to increase the annual contract by \$160,000, extend the contract one year, and adjust Truck parts pricing; and

WHEREFORE, the Parties entered into a Second Amendment to increase the contract amount by an additional One Hundred Sixty Thousand (\$160,000), extend the contract for one (1) additional one-year term, and adjust Truck parts pricing; and

WHEREFORE, the Parties desire to enter into a Third Amendment to increase the contract amount by an additional One Hundred Sixty Thousand (\$160,000), extend the contract for one (1) additional one-year term until July 31, 2024;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 3 of the Contract is hereby amended to read as follows.

"The term of this Contract shall commence on August 1, 2019, and shall terminate at midnight on July 31, 2024, unless sooner terminated as provided herein. The City may terminate this Contract by giving thirty (30) days prior notice of the termination to
