HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

That the City Council adopt California Form 806 as required by Fair Political Practices Commission (FPPC) Regulation 18705.5, and direct the City Clerk to post and maintain Form 806 on the City Clerk Department home page.

DISCUSSION

In May 2012, the FPPC adopted Regulation 18705.5 which authorizes public officials to vote on their own appointments to compensated positions on various types of City and non-City boards and commissions. Pursuant to the new regulation, public agencies are required to list: [a] each appointed position for which compensation is paid; [b] the salary or stipend for each appointed position; [c] the name of the public official who has been appointed to the position; [d] the name of the public official, if any, who has been appointed as an alternate, and [c] the term of the position.

On October 24, 2012, the City Clerk Department posted on its home page a current Form 806 based on the City Council's appointments to outside boards on October 16, 2012.

TIMING CONSIDERATIONS

Adoption of the suggested action will bring those appointments into compliance with the new regulation.




