

1 FIRST AMENDMENT TO CONTRACT NO. 34197

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34197 is entered into, in
4 duplicate, effective as of July 20, 2017, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on July 18,
6 2017, by and between LEADERSHIP LONG BEACH INC., a California corporation with
7 offices located at 743 Atlantic Avenue, Long Beach, California 90813 ("Contractor") and
8 the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for
9 Pacific Gateway Workforce Investment Network.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34197 whereby Contractor agreed to provide leadership development and mentoring
12 services to youth program participants; and

13 WHEREAS, the Parties desire to extend the term and add \$50,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2.A. of Contract No. 34197 is hereby amended to read as
17 follows:

18 "A. The term of this Contract ("Term") shall be deemed to have
19 commenced as of July 1, 2015, and unless sooner terminated pursuant to the
20 provisions hereof, shall terminate on September 30, 2017. Either of the parties
21 hereto shall have the right to terminate this Contract in its entirety at any time during
22 the Term for any or no reason whatsoever by giving fifteen (15) days prior written
23 notice of termination to the other party. City shall have the additional right to cancel
24 any part of this Contract at any time during the Term for any reason whatsoever by
25 giving fifteen (15) days' notice of such cancellation to the Contractor."

26 2. Section 5.A. of Contract No. 34197 is hereby amended to read as
27 follows:

28 "A. The total amount which shall be payable by City to Contractor for

1 Contractor's allowable services during the Term shall not exceed Two Hundred Seventy
2 Thousand Dollars (\$270,000)."

3 3. Except as expressly modified herein, all of the terms and conditions
4 contained in Contract No. 34197 are ratified and confirmed and shall remain in full force
5 and effect.
