
Contract No. 33584 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 9. Current permits, licenses, insurance and other required information are attached as Addendum No. 1.



RE: Notice of Rate Adjustment January 2016

Dear Ms. Takii,

I am writing today to inform you of a change we are applying in your bill rates to address new laws regarding the California State Minimum Wage and the Federal ACA program.

**Effective January 1, 2016 the California Minimum Wage will increase from \$9.00 per hour to \$10.00 per hour.** Pursuant to our contract with the City of Long Beach we will apply this new minimum wage to the pay rates for the officers assigned to your facilities. As a result, we will be increasing our bill rates to adjust for this statutory wage regulation. Your rates will increase by the one dollar plus taxes and insurance.

**Effective January 1, 2015 - GSS, in compliance with the Affordable Care Act (ACA) began to offer basic medical insurance to our employees through Kaiser.** This plan meets all Federal regulations including those for value and affordability. As such, GSS has received an increase in operating cost in the form of a tax on employee wages equal to the cost of the plan minus the employee contribution. We anticipate an increase in officer participation due to the increase in tax penalties leveled by the IRS. As a result, GSS will be increasing our bill rates to adjust for this increased participation. Your rates will increase for ACA by \$0.42 per hour.

This rate change will take effect with the billing cycle beginning on January 1, 2016.
