A RESOLUTION OF THE OVERSIGHT BOARD OF THE CITY OF LONG BEACH AS THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A SETTLEMENT AGREEMENT WITH GREAT AMERICAN INSURANCE COMPANY AND/OR ARMAND GONZALES, INC. DBA GONZALES CONSTRUCTION

WHEREAS, on March 15, 2010, the former Redevelopment Agency of the City of Long Beach ("RDA") entered into a construction contract ("Contract") with Armand Gonzales, Inc. dba Gonzales Construction ("Gonzales") for the construction of Fire Station 12 and Emergency Resource Center ("Project") located at 1199 East Artesia Boulevard; and

WHEREAS, the City of Long Beach, as Successor Agency to the Redevelopment Agency of the City of Long Beach ("Successor Agency"), has assumed all rights and obligations of the RDA under the Contract; and

WHEREAS, on November 15, 2011, the RDA declared Gonzales in default of the contract and made demand upon Great American Insurance Company ("Surety"), the bonding company for Gonzales, to perform and complete the Project; and

WHEREAS, the Successor Agency, Surety, and Gonzales, in an attempt to complete the Project in a timely and cost-effective manner, agreed to allow Gonzales to continue work on the Project; and

WHEREAS, on June 14, 2012, Gonzales filed a lawsuit against the Successor Agency alleging breach of contract; and

WHEREAS, on October 4, 2012, the City sent a letter to Gonzales declaring

it in default of the terms of the Contract; and

WHEREAS, on November 8, 2012, the Successor Agency terminated the Contract with Gonzales; and

WHEREAS, in an attempt to preserve the work already completed and expedite completion of the Project, it is proposed that the Successor Agency and Surety enter into a Takeover Agreement; and

WHEREAS, to avoid the inconvenience, expense and uncertainty of further litigation, a Settlement Agreement is proposed to be executed by the Successor Agency and Gonzales contemporaneously with the Takeover Agreement;

NOW, THEREFORE, the Oversight Board of the City of Long Beach as the Successor Agency to the Redevelopment Agency of the City of Long Beach ("Oversight Board") resolves as follows:

Section 1. Approve the decision of the Successor Agency to authorize the City Manager to execute (i) a Takeover Agreement with Great American Insurance Company; and (ii) a Settlement Agreement with Great American Insurance Company and/or Armand Gonzales, Inc. dba Gonzales Construction.

Section 2. This resolution shall take effect immediately upon its adoption by the Oversight Board, and the City Clerk shall certify the vote adopting this resolution.
