3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER OR DESIGNEE TO EXECUTE A CONTRACT
6 WITH THE TERMINIX INTERNATIONAL COMPANY
7 LIMITED PARTNERSHIP, FOR PEST CONTROL
8 PRODUCTS AND SERVICES, ON THE SAME TERMS AND
9 CONDITIONS AFFORDED TO THE UNIVERSITY OF
10 NEBRASKA THROUGH OMNIA PARTNERS, IN AN
11 ANNUAL AMOUNT NOT TO EXCEED \$200,000, UNTIL THE
12 UNIVERSITY OF NEBRASKA CONTRACT EXPIRES ON
13 APRIL 8, 2026, WITH THE OPTION TO RENEW FOR AS
14 LONG AS THE UNIVERSITY OF NEBRASKA CONTRACT IS
15 IN EFFECT, AT THE DISCRETION OF THE CITY
16 MANAGER

18 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the
19 City Manager to enter into a contract on behalf of the City, in writing or otherwise, without
20 advertising for bids, for services, supplies, materials, equipment or labor, with other
21 government agencies, when authorized by resolution; and

22 WHEREAS, the City requires pest control products and services; and

23 WHEREAS, the University of Nebraska through Omnia Partners, has a
24 contract with The Terminix International Company Limited Partnership for pest control
25 products and services, Contract No. 3280-20-7210-01 ("University of Nebraska Contract");
26 and

27 WHEREAS, the City's participation in the University of Nebraska Contract will
28 facilitate timely acquisition of the pest control products and services as well as provide

1 considerable cost benefits to the City; and

2 WHEREAS, if the City had to go to formal bid rather than participate in the
3 University of Nebraska Contract considerably more funds would be required;

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
5 follows:

6 Section 1. The City Manager or designee is hereby authorized to enter an
7 agreement with The Terminix International Company Limited Partnership for pest control
8 products and services, of the same kind identified in the University of Nebraska Contract
9 in an annual amount not to exceed Two Hundred Thousand Dollars (\$200,000), until
10 University of Nebraska Contract No. 3280-20-7210-01 expires on April 8, 2026, with the
11 option to renew for as long as University of Nebraska Contract No. 3280-20-7210-01 is in
12 effect, at the discretion of the City Manager.

13 Section 2. This resolution shall take effect immediately upon its adoption
14 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
