3 A RESOLUTION OF THE CITY COUNCIL OF  
4 THE CITY OF LONG BEACH AUTHORIZING THE  
5 CITY MANAGER TO PURCHASE ONE AERIAL  
6 LADDER TRUCK THROUGH THE CONTRACT  
7 BETWEEN THE CITY OF GRAND RAPIDS AND  
8 SEAGRAVE FIRE APPARATUS, LLC

10 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits  
11 the City to purchase services, supplies, materials, equipment and labor with other  
12 government agencies by purchasing under their contracts on a voluntary and selective  
13 basis when authorized by resolution; and

14 WHEREAS, the City of Long Beach desires to purchase one (1) aerial  
15 ladder truck; and

16 WHEREAS, the City of Grand Rapids has a contract for the purchase of  
17 this truck through its Purchase Order No. PO0400158808 and accompanying contract  
18 ("Grand Rapids Contract"); and

19 WHEREAS, City's participation in the Grand Rapids Contract will facilitate  
20 acquisition of this truck as well as provide considerable costs benefits to the City; and

21 WHEREAS, if the City had to go to formal bid rather than participate in the  
22 Grand Rapids Contract considerably more funds would be required;

23 NOW, THEREFORE, the City Council of the City of Long Beach resolves  
24 as follows:

25 Section 1. The above recitals are true and correct and are incorporated  
26 hereby by this reference.

27 Sec. 2. The City Manager of the City of Long Beach is hereby authorized  
28 to enter an agreement with Seagrave Fire Apparatus, LLC. to purchase one (1) aerial

1 ladder truck of substantially the same type and kind purchased by the City of Grand  
2 Rapids pursuant to the Grand Rapids Contract except as modified by mutual  
3 agreement of the City of Long Beach and Seagrave Fire Apparatus LLC and the  
4 purchase by the City of Long Beach shall be on the same terms and conditions afforded  
5 to the City of Grand Rapids in an amount not to exceed \$685,636.00 plus tax, for a  
6 period extending until the warranty on the truck expires.


7 Sec. 3. This resolution shall take effect immediately upon its adoption by  
8 the City Council, and the City Clerk shall certify the vote adopting this resolution.
