3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32791 is made and  
4 entered, in duplicate, as of January 5, 2015 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 November 18, 2014, by and between PARADIES-LONG BEACH II, LLC, a California  
7 limited liability company ("Concessionaire"), with a place of business at 5950 Fulton  
8 Industrial Blvd., SW, Atlanta, Georgia 30336, and the CITY OF LONG BEACH, a  
9 municipal corporation ("City").

10 WHEREAS, the parties entered into Agreement No. 32791 (the  
11 "Agreement") whereby Concessionaire agreed to provide food and beverage and  
12 specialty food/beverage at the Long Beach Airport; and

13 WHEREAS, the parties desire to extend the term;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
15 the Agreement and in this First Amendment, the parties agree as follows:

16 1. City and Concessionaire hereby acknowledge City's exercise of each  
17 of its five (5) options to extend the term of the Agreement, extending the termination date  
18 of the Agreement to November 30, 2027. City shall have no further extension options  
19 under the Agreement.

20 2. Except as expressly amended in this First Amendment, all terms and  
21 conditions in Agreement No. 32791 are ratified and confirmed and shall remain in full  
22 force and effect.
