THIS FIRST AMENDMENT TO AGREEMENT NO. 34413 ("First Agreement") is made and entered, in duplicate, as of October 14, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 3, 2015, by and between CALIFORNIA STATE UNIVERSITY, LONG BEACH RESEARCH FOUNDATION, CENTER FOR HEALTH EQUITY RESEARCH ("CSULB-CHER"), with a place of business at 6300 State University Drive, Suite 332, Long Beach, California 90815, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City is the fiscal agent and grantee for the federally-funded continuation support for the National Forum on Youth Violence Prevention, State and Community Development grant program ("Forum Grant Program" and also referred to as the "DOJ Safe Schools Grant"); and

WHEREAS, City and CSULB-CHER entered into Agreement No 34413 (the "Agreement") for the purpose of developing and executing an evaluation of the Forum Grant Program; and

WHEREAS, as City received additional funding to continue the work, City and CSULB-CHER desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 4 of the Agreement is hereby amended to read as follows:
- "4. <u>TERM</u>. The term of this Agreement shall commence at midnight on October 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2017, unless otherwise extended by the City at its sole discretion or sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
