FIRST AMENDMENT TO AGREEMENT NO. 36399

THIS FIRST AMENDMENT TO AGREEMENT NO. 36399 is made and entered, in duplicate, as of March 17, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 18, 2022, by and between JOHN GROSS dba FINANCIAL MANAGEMENT AND SYSTEMS CONSULTING, a sole proprietor ("Consultant"), with a place of business at 5652 E. Grandview Road, Scottsdale, Arizona 85254, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Enterprise Resource Planning embedded quality assurance and other sponsor support services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36399 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to extend the term for an additional six-month period to September 30, 2023;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows.

"TERM. The term of this Agreement shall commence at midnight on October 1, 2022, and shall terminate at 11:59 p.m. on September 30, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36399 are ratified and confirmed and shall remain in full force and effect.

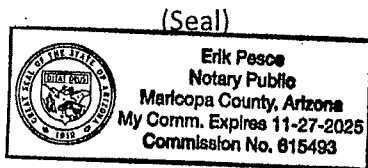
