As per Section 28 of the Civil Service Rules and Regulations, I request Civil Service Commission authorization to certify candidates, on a selective certification basis, to the classification of **Public Health Professional III (Chief Environmental Health Specialist)** for **Requisition #HE 12-014**.

The **Public Health Professional III** (Chief Environmental Health Specialist) requires skills, knowledge and abilities to implement and oversee the administration of the following environmental health inspection programs: Food Facilities, Multi-Unit Housing, Recreational Water, Vector Control and Hazardous Materials and other programs as assigned. The successful candidate will, at minimum, possess a Bachelor of Science Degree from an accredited four-year college or university with coursework in environmental health, public health, environmental analysis, public administration, business or a closely related field.

Authorization to receive a list of selectively certified candidates from eligible lists generated by the Selective Certification Requests will increase the Department of Health and Human Services capacity to provide effective, high quality, and timely services to members of the Long Beach community in accordance with local, county, state and federal requirements.
