

AMENDMENT NO. TWO TO CONTRACT NO. 32081 32081

RE: Amendment No. Two to Contract No. 32081 for furnishing and delivering domestic gas meters to the City of Long Beach (BPG011000017)

This Amendment to Contract No. 32081 is made and entered as of May 14, 2013, by and between the CITY OF LONG BEACH, a municipal corporation, and Tri-Pacific Supply, Inc. (Contractor)


Contract No. 32081 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to April 15, 2014.
- 2. \$500,000 has been added to the 2nd renewal term for a total ("not to exceed") amount of \$1,500,000.
- 3. Prices during this period shall remain firm.
- 4. The price for certain items shall be increased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 5. The price for certain items shall be decreased as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 6. The discount offered to the City is increased by ____ %
- 7. The items or locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby deleted from the Contract.
- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance and other required information are attached as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.





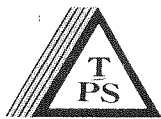

Dear Ms. King:

We are implementing an increase on item #1 Exhibit A. Original contract price from April 2011 was \$55.25 for Sensus R275 meter. We held the price flat for the second year of the contract with no increase.

For the second amendment we are proposing an increase of 4.1%. This would increase price for Sensus R275 meter to \$57.45.

Contract limits increase to 5% per year. Our proposed increase over the two years would average 2.05% well within the guidelines.

We are hopeful this meets with your approval.
