SECOND AMENDMENT TO AGREEMENT NO. 34108

THIS SECOND AMENDMENT TO AGREEMENT NO. 34108 is made and entered, in duplicate, as of August 22, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 21, 2015, by and between PERCEPTIVE ENTERPRISES, INC., a California corporation ("Consultant"), with a place of business at 844 Colorado Boulevard, Suite 204, Los Angeles, California 90041, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34108 (the "Agreement") whereby Consultant agreed to provide as-needed professional compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$100,000 and extend the term to June 1, 2019; and

WHEREAS, the Parties desire to extend the term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on November 15, 2015, and shall terminate at 11:59 p.m. on November 14, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34108 are ratified and confirmed and shall remain in full force and effect.
