

1 C. Permittee shall maintain minimum hours of operation from
2 10:00 a.m. to 4:00 p.m., on weekends, from April 1 through September 30 of each
3 Permit Year.

4 D. There shall be no subletting without the prior written approval
5 of the Director.

6 E. No cars or trucks shall drive onto the turf within the Permit Area
7 without Permittee placing protective plywood over the affected turf.

8 F. Permittee shall provide City staff with a quarterly schedule of
9 large groups to facilitate the coordination of facilities and staffing within El Dorado
10 Park.”

11 2. Section 2 of the Permit is amended to read as follows:

12 “2. TERM. The term of this Permit shall commence at 12:01 a.m. on
13 March 1, 2008, and shall terminate at midnight on September 30, 2018, unless revoked
14 prior to said expiration date as provided herein. The Director may, at his sole discretion,
15 renew this Permit for one (1) additional one-year term. Either Party may cancel this Permit
16 for any reason or no reason by giving thirty (30) days written notice of cancellation to the
17 other Party. On revocation or cancellation, Permittee shall immediately cease operations
18 and remove Permittee’s items from the Permit Area.”

19 3. Permittee shall maintain applicable insurance at levels determined
20 and approved to sufficiency by the City’s Risk Manager.

21 4. Except as expressly amended in this Third Amendment, all terms,
22 conditions and restrictions in Permit No. 30673 are ratified and confirmed and shall remain
23 in full force and effect.
