Adopt Specifications WD-54-22 for the Golden Avenue Water Main Replacement Project (MC-5223) and authorize the General Manager to sign a construction contract with Gutierrez Pipeline, Inc., in the amount of \$758,971.

Executive Summary

On January 11 and 18, 2023, a notice inviting bids was published for the Golden Avenue Water Main Replacement Project in accordance with Public Contract Code Section 22037. The Project consists of all work related to the replacement of the existing 6-inch ductile iron water main and 48 copper water services with new non-metallic piping, replacement of existing water valves in the project limits, and the replacement of three fire hydrants along the project limits in Golden Avenue between Spring Street and 32nd Street.

On February 8, 2023, five bids were received and opened. A bid tabulation is attached. The lowest responsive bid submitted by Gutierrez Pipeline, Inc., in the amount of \$758,971 was found to be in conformance with the bid documents.

The Engineer's estimate is \$1,143,000.

Recommendation

Adopt Specifications WD-54-22 for the Golden Avenue Water Main Replacement Project (MC-5223) and authorize the General Manager to sign a construction contract with Gutierrez Pipeline, Inc., in the amount of \$758,971.

Fiscal Impact: The total FY 23 cost of the contract to the Water Fund will be \$758,971. The costs are included in the Water Fund FY 23 CIP budget.
