

1 FIRST AMENDMENT TO CONTRACT NO. 34584

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34584 is made and
4 entered, in duplicate, as of June 14, 2017 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting held on June 6,
6 2017, by and between ARB, INC., a California corporation ("Contractor"), whose address
7 is 26000 Commercenter Drive, Lake Forest, California 92630, and the CITY OF LONG
8 BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
10 34584 (the "Contract") whereby Contractor agreed to provide the work described in Plans
11 and Specifications No. G-332; and

12 WHEREAS, the Parties desire to increase the annual Contract amount by
13 Two Million Dollars (\$2,000,000) for a revised annual amount not to exceed Four Million
14 Five Hundred Thousand Dollars (\$4,500,000);

15 NOW, THEREFORE, in consideration of the mutual terms and conditions
16 herein contained, the Parties agree as follows:

17 1. Section 2.A. of the Contract is hereby amended to read as follows:

18 "A. City shall pay to Contractor the amount(s) for materials and work
19 identified in Contractor's Bid for the Annual Contract for Plastic Gas Pipeline Construction
20 in the City of Long Beach, California, attached hereto as Exhibit "A"; provided, however,
21 that the total compensation to Contractor shall not exceed an annual amount of Four Million
22 Five Hundred Thousand Dollars (\$4,500,000) during the term of this Contract."




