AN ORDINANCE OF THE CITY COUNCIL OF THE					
CITY OF LONG BEACH AMENDING THE LONG BEACH					
MUNICIPAL CODE BY ADDING SUBSECTIONS DD, EE,					
FF and GG TO SECTION 10.22.080 RELATING TO					
PARKING VEHICLES FOR SALE					

WHEREAS, the City has received numerous complaints from citizens regarding the parking of vehicles with "For Sale" signs on Livingston Drive between Quincy Avenue and Prospect Avenue, Lois Lane between Bennett Avenue and Quincy Avenue, 2nd Street from Sorrento Drive to Naples Plaza and Naples Plaza from 2nd Street to The Toledo; and

WHEREAS, with the increase of vehicles parking with "For Sale" signs on them in the areas described above, such activity is creating unsafe traffic conditions because motorists interrupt traffic flow to stop or slow down to observe the vehicles displaying "For Sale" signs which creates the potential for traffic collisions;

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 10.22.080 of the Long Beach Municipal Code is hereby amended by adding Subsections DD, EE, FF and GG to read as follows:

- DD. Livingston Drive between Quincy Avenue and Prospect Avenue.
 - EE. Lois Lane between Bennett Avenue and Quincy Avenue.
 - FF. 2nd Street from Sorrento Drive to Naples Plaza.
 - GG. Naples Plaza from 2nd Street to The Toledo.
