1. Adoption of a Local Hire Policy & Project Labor Agreement (PLA) simultaneously;
2. Local, low-income hiring requirements (not "best efforts" or "goals");
3. Local, low-income hiring based on work hours (not positions);
4. A definition of "local" that prioritizes Long Beach residents with barriers to employment;
5. The utilization of an independent, third-party jobs coordinator.
