SECOND AMENDMENT TO CONTRACT NO. 32403

WHEREAS, the parties entered Contract No. 32403 whereby Contractor agreed to provide such services; and

WHEREAS, the parties entered a First Amendment that amended the Scope of Work attached to the Contract and increased the Contract amount; and

WHEREAS, the parties again desire to amend the Scope of Work attached to the Contract and increase the Contract amount;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Contract No. 32403 and herein, the parties agree as follows:

- 1. The Scope of Work in Exhibit "A" to the Contract is hereby amended in accordance with Exhibit "A-2", attached hereto and incorporated by this reference.
- 2. Section 2.A. of Contract No. 32403 is hereby amended to read as follows:

"2. PRICE AND PAYMENT.

A. City shall pay to Contractor the amount(s) for materials and work identified in Contractor's "Bid for the Restoration and Improvements of Colorado Lagoon, Phase 1, Part 2, in the City of Long Beach, California," attached

hereto as Exhibit "A" and as amended by Exhibit "A-2"; provided, however, that City shall not pay more than Seven Million Five Hundred One Thousand Six Hundred Dollars (\$7,501,600) for the term of the Contract."

 Except as expressly modified herein, all of the terms and conditions contained in Contract No. 32403 are ratified and confirmed and shall remain in full force and effect.
