1 SIXTH AMENDMENT TO AGREEMENT NO. 33772

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 33772 is made and
4 entered, in duplicate, as of July 11, 2018 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on December 2,
6 2014, by and between WILLDAN ENGINEERING, a California corporation ("Consultant"),
7 with a place of business at 13191 Crossroads Parkway North, Suite 405, Industry,
8 California 91746-3443, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with on-call planning consulting services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 33772 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 increase the total not to exceed Agreement amount to \$225,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to increase the total not to exceed Agreement amount to \$475,000; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to increase the total not to exceed Agreement amount to \$975,000; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to increase the total not to exceed Agreement amount to \$1,475,000 and extend the term;
21 and

22 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
23 extend the term; and

24 WHEREAS, the Parties desire to add \$600,000 to the Agreement for a total
25 not to exceed amount of \$2,075,000;

26 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
27 conditions herein contained, the Parties agree as follows:

28 1. Section 1.A of the Agreement is hereby amended to read as follows:

1 "A. Consultant shall furnish specialized services more particularly
2 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
3 accordance with the standards of the profession, and City shall pay for these services in
4 the manner described below, not to exceed Two Million Seventy-Five Thousand Dollars
5 (\$2,075,000), at the rates or charges shown in Exhibit "B".

6 2. Except as expressly modified herein, all of the terms and conditions
7 contained in Agreement No. 33772 are ratified and confirmed and shall remain in full force
8 and effect.

9 IN WITNESS WHEREOF, the Parties have caused this document to be duly
10 executed with all formalities required by law as of the date first stated above.
