## Our Outcomes

**Transparency** - We will increase departmental integrity and accountability with the communities in which the officers serve.

**Screening** - We will offer immediate and significant cost savings in officer applicant verification and background checks.

**Research** - We will offer our expert analysis and publication of data-driven trends and patterns of misconduct causalities.

**Policy** – We continue to meet and brief state and federal legislators, interested in the LEWIS Registry becoming a component of future legislation.





## Our Support

During the winter 2020, we conducted a YouGov survey to ascertain the level of support for a registry of the type being proposed by Rep. Karen Bass (D-CA) in the George Floyd Justice in Policing Act 2021.

Our study concluded that support for the registry is weighted as follows across political parties:

- Republican: 73.45%
- Democrat: 90.75%
- Independent: 76.19%
- Total: 80%





## Our Support

Based on the results from a CivicPulse survey conducted in April & May of 2021, support for a registry such as LEWIS among law enforcement agencies are represented as follows:

Do you support creating a national registry of law enforcement officers who have been fired for misconduct?

- Yes: 76.1%
- No: 23.9%

If there existed a national registry of law enforcement officers who have been fired for misconduct, would your agency make checking this registry a part of your applicant screening process?

- Yes: 94.7%
- No: 5.3%

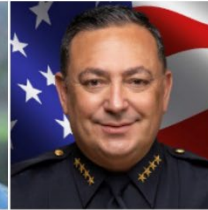
