
1	SECOND AMENDMENT TO AGREEMENT NO. 28247

7	("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

10	with As-Needed Architectural & Engineering Design ('Project"); and

13	the Agreement and in this Amendment, the parties agree as follows:

15	"2. <u>TERM</u> . The term of this Agreement shall commence at midnight on
16	March 25, 2003, and shall terminate at 11:59 p.m. on March 24, 2007, unless sooner
17	terminated as provided in this Agreement, or unless the services to be performed under
18	this Agreement or the Project is completed sooner."
19	2. Except as set forth in this Second Amendment to Agreement No.
20	28247, all terms and conditions of the Agreement are ratified and confirmed and shall
21	remain in full force and effect.
