1 FIRST AMENDMENT TO AGREEMENT NO. 30850

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30850 is made and
4 entered, in duplicate, as of June 1, 2011 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on
6 July 8, 2008, by and between ASSOCIATED ENGINEERS, INC., a California corporation
7 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, the parties entered Agreement No. 30850 whereby Consultant
9 agreed to perform As-Needed Airport Planning, Engineering, and Architectural Consulting
10 Services ("Project"); and

11 WHEREAS, the parties desire to extend the term, update the fee schedule,
12 and increase the Agreement amount by \$500,000;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions in
14 the Agreement and in this First Amendment, the parties agree as follows:

15 1. Section 1.A. of Agreement No. 30850 is hereby amended to read as
16 follows:

17 "1. SCOPE OF WORK OR SERVICES.

18 A. Consultant shall furnish specialized services more particularly
19 described in Exhibit "A", attached to this Agreement and incorporated by this reference,
20 in accordance with the standards of the profession, and City shall pay for these services
21 in the manner described below, not to exceed One Million Five Hundred Thousand
22 Dollars (\$1,500,000.00), at the rates or charges shown in Exhibit "A".

23 2. Exhibit "A" attached to this Amendment is hereby superseded and
24 replaces in its entirety Exhibit "A" currently attached to the Agreement.

25 3. Section 2 of Agreement No. 30850 is hereby amended to read as
26 follows:

27 "2. TERM. The term of this Agreement shall commence at midnight on
28 August 1, 2008, and shall terminate at 11:59 p.m. on July 31, 2014, unless sooner

1 terminated as provided in this Agreement, or unless the services or the Project is
2 completed sooner.”

3 4. Except as expressly amended in this First Amendment, all terms and
4 conditions in Agreement No. 30850 are ratified and confirmed and shall remain in full
5 force and effect.
