The City Clerk Department budget contains the appropriations necessary for conduct of the April 8, 2008, Primary Nominating Election.

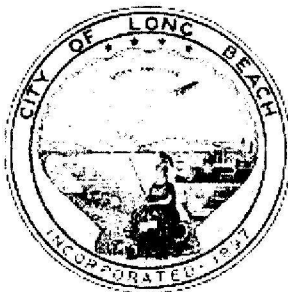





14 1.21.070; and
