

RESOLUTION NO. RES-07-0005

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO ACQUIRE ONE (1) POT HOLE PATCH TRUCK WITH THE OPTION TO ACQUIRE A SECOND POT HOLE PATCH TRUCK THROUGH THE PURCHASE ORDER BETWEEN THE COUNTY OF SAN BERNARDINO AND HAAKER EQUIPMENT COMPANY

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase one (1) pot hole patch truck and may desire to purchase a second pot hole patch truck; and

WHEREAS, the County of San Bernardino has a contract for the purchase of these pot hole patch trucks from Haaker Equipment Company, Purchase Order No. G1929; and

WHEREAS, City's participation in the County of San Bernardino Purchase Order will facilitate acquisition of the pot hole patch truck(s) as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the County of San Bernardino Purchase Order considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Haaker Equipment Company to purchase one (1) pot hole patch truck with the option to purchase a second pot hole patch truck of substantially the same type and kind purchased by the County of San Bernardino pursuant to the County of San Bernardino Purchase Order except as modified by mutual agreement of the City of Long Beach and Haaker Equipment Company, and the purchase by the City of Long Beach shall be on the same terms and conditions afforded to the County of San Bernardino in an amount per truck not to exceed \$209,923.81 including tax with a ten percent contingency for additional equipment.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
