FOURTH AMENDMENT TO AGREEMENT NO. 33842

THIS FOURTH AMENDMENT TO AGREEMENT NO. 33842 is made and entered, in duplicate, as of March 8, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015, by and between ALTA PLANNING + DESIGN, INC., a California corporation ("Consultant"), with a place of business at 617 W. 7th Street, Suite 505, Los Angeles, California 90017, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, City and Consultant (the "Parties") entered Agreement No. 33842 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to decrease the amount by \$200,000 for a total not to exceed amount of \$300,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the amount by \$200,000 for a total not to exceed amount of \$500,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the amount by \$200,000 for a total not to exceed amount of \$700,000; and

WHEREAS, the Parties desire to increase the amount by \$400,000 for a total not to exceed amount of \$1,100,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in

- 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33842 are ratified and confirmed and shall remain in full force and effect.
