

1 FOURTH AMENDMENT TO AGREEMENT NO. 33842

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 33842 is made and  
4 entered, in duplicate, as of March 8, 2018, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April  
6 7, 2015, by and between ALTA PLANNING + DESIGN, INC., a California corporation  
7 (“Consultant”), with a place of business at 617 W. 7th Street, Suite 505, Los Angeles,  
8 California 90017, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with as-needed traffic engineering, transportation planning and  
11 related technical and professional services; and

12 WHEREAS, City and Consultant (the “Parties”) entered Agreement No.  
13 33842 (the “Agreement”) whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement  
15 to decrease the amount by \$200,000 for a total not to exceed amount of \$300,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the  
17 Agreement to increase the amount by \$200,000 for a total not to exceed amount of  
18 \$500,000; and

19 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
20 to increase the amount by \$200,000 for a total not to exceed amount of \$700,000; and

21 WHEREAS, the Parties desire to increase the amount by \$400,000 for a  
22 total not to exceed amount of \$1,100,000 and extend the term one (1) additional one-year  
23 period;

24 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
25 conditions herein contained, the Parties agree as follows:

- 26 1. Section 1.A. of the Agreement is hereby amended to read as follows:  
27 “A. Consultant shall furnish specialized services more particularly  
28 described in Exhibit “A”, attached to this Agreement and incorporated by this reference, in

1 accordance with the standards of the profession, and City shall pay for these services in  
2 the manner described below, not to exceed One Million One Hundred Thousand Dollars  
3 (\$1,100,000), at the rates or charges shown in Exhibit "B".

4 2. Section 2 of the Agreement is hereby amended to read as follows:

5 "2. TERM. The term of this Agreement shall commence at midnight on  
6 June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2019, unless sooner  
7 terminated as provided in this Agreement, or unless the services or the Project is  
8 completed sooner. The Parties have the option to extend the term one (1) additional one-  
9 year period."

10 3. Except as expressly modified herein, all of the terms and conditions  
11 contained in Agreement No. 33842 are ratified and confirmed and shall remain in full  
12 force and effect.
