A motion was made by Chair Gabelich, seconded by Member Reyes Uranga, to approve recommendation to require sprinkler retrofitting of high rises and multi-families and residential units containing 50 or more units, to provide an alternative compliance program through a fire education and preparedness program that would include requiring fire extinguishers in every unit; an annual certification and training program; an emergency evacuation plan, specific to the building; mandatory semi-annual inspections to ensure fire detectors and extinguishers are in good working order, semi-annual emergency preparedness exercises including evacuation drills, and other recommendations for life safety measures; and request the Fire Department to form a focus group of key stakeholders to help develop the plan and report back to committee within 8 weeks with their recommendations on the components of an alternative compliance program; fee structure for full cost recovery for the Fire Department and other City services for enforcement of the program, and thresholds for determining non-compliance and alternative compliance programs, after which sprinkler retrofitting requirement would be enforced.
