RECOMMENDATION:

DISCUSSION

On November 8, 2011, the City Council adopted a resolution calling and giving notice of the Primary Nominating Election.

With the close of the candidate nomination period on January 13, 2012, the City Clerk is required to submit the attached resolution for adoption pursuant to City Charter Section 1907, which serves to certify the list of candidates who were duly nominated, and identify the order in which their names will appear on the official ballot.

The recommended resolution includes a listing of candidates for contests in the Long Beach Unified School District and the Long Beach Community College District as certified by the Los Angeles County Registrar-Recorder/County Clerk. Candidates for the foregoing contests are listed in the order in which they will appear on the official ballot.

TIMING CONSIDERATIONS

Approval of the recommended action at this time will allow the City Clerk Department to prepare the official ballot, sample ballot and ballot pamphlet.

FISCAL IMPACT


The City Clerk Department budget contains the appropriations necessary for conduct of the April 10, 2012, Primary Nominating Election.

9 WHEREAS, in accordance with the Long Beach City Charter, the City
10 Council has called a municipal primary nominating election to be held in the City of Long
11 Beach on April 10, 2012, for the City Council offices in Council Districts Two, Four, and
12 Eight, and for the offices of the Board of Trustees of the Long Beach Community College
13 District Four and Board of Education of the Long Beach Unified School Districts Two and
14 Four; and

15 WHEREAS, the primary nominating election in Council District Six has been
16 cancelled pursuant to Long Beach Municipal Code Section 1.21.070; and

17 WHEREAS, in accordance with City Charter Section 1907, the City Clerk
18 has submitted to the City Council a certified list of the candidates which have been duly
19 nominated as required by law for the elective offices to be voted on at said election, and
20 the names are listed for each such office in the order of the randomized alphabet
21 selected by the Secretary of State in a drawing held on January 19, 2012, pursuant to
22 California Elections Code Section 13112.
