

1 FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00061

3 THIS FIRST AMENDMENT TO RIGHT OF ENTRY PERMIT NO. P-00061
4 is made and entered, in duplicate, as of August 30, 2016, for reference purposes only,
5 pursuant to a minute order adopted by the City Council of the City of Long Beach at its
6 meeting on August 23, 2016, by and between the CITY OF LONG BEACH, a municipal
7 corporation ("City") and LONG BEACH UNIFIED SCHOOL DISTRICT ("Permittee").

8 WHEREAS, the City granted Permittee permission to enter the City-owned
9 property described in Exhibit "A" attached to Permit No. P-00061 (the "Permit") to make
10 improvements to the baseball field and soccer field overlay at Houghton Park, located at
11 6301 Myrtle Avenue, Long Beach, California 90805; and

12 WHEREAS, due to a variety of delays, Permittee has been unable to
13 complete all of the improvements to the Houghton park baseball field and soccer field
14 overlay in the time originally approved; and

15 WHEREAS, Permittee is requesting an extension of the Right-of-Entry
16 Permit for an additional fourteen (14) months in order to complete the improvements;

17 NOW, THEREFORE, in consideration of the mutual terms and conditions in
18 Permit No. P-00061, the parties agree as follows:

19 1. Section 3.A of the Permit is hereby amended in its entirety to read as
20 follows:

21 "A. Permission to enter shall begin on December 1, 2014, and
22 continue through January 31, 2018, unless the services to be performed hereunder or the
23 project is completed sooner. The term may be extended for one (1) additional one-year
24 period at the discretion of the City Manager."

25 2. Except as expressly stated herein, all of the terms, covenants, and
26 conditions of Permit No. P-00061 are ratified and confirmed and shall remain in full force
27 and effect.
