

FIRST AMENDMENT TO CONTRACT NO. 34951**34951**

THIS FIRST AMENDMENT TO CONTRACT NO. 34951 is made and entered into, in duplicate, effective as of December 19, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on December 19, 2017, by and between CALIFORNIA STATE UNIVERSITY, DOMINGUEZ HILLS, a public education institution ("Contractor"), with offices located at 1000 East Victoria Street, Carson, California 90747, and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34951 (the "Contract") whereby Contractor agreed to provide vocational skills training and educational support in various sectors to Pacific Gateway participants; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$110,000 to the Contract;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2.A. of the Contract is hereby amended to read as follows:

"A. The term of this Contract ("Term") shall be deemed to have commenced as of October 15, 2016, and unless sooner terminated pursuant to the provisions hereof, shall terminate on October 14, 2019. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to the Contractor."

2. Section 5.A. of the Contract is hereby amended to read as follows:

"A. The total amount which shall be payable by City to Contractor

1 for Contractor's allowable services during the Term shall not exceed Three Hundred  
2 Thirty Thousand Dollars (\$330,000)."

3 3. Except as expressly modified herein, all of the terms and conditions  
4 contained in Contract No. 34951 are ratified and confirmed and shall remain in full force  
5 and effect.
