SECOND AMENDMENT TO AGREEMENT NO. 29704

THIS SECOND AMENDMENT TO AGREEMENT NO. 29704 is made and entered, in duplicate, as of April 15, 2010 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 23, 2006, by and between POST, BUCKLEY, SCHUH & JERNIGAN, INC. WHICH WILL DO BUSINESS IN CALIFORNIA AS PBS&J, a Florida corporation ("Consultant"), with a place of business at 625 The City Drive, Suite 200, Orange, California 92868-4946, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 29704 whereby Consultant agreed to provide As-Needed Multi-Discipline Design Services ("Project"); and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 2 of Agreement No. 29704 is hereby amended in its entirety to read as follows:

"2. TERM. The initial term of this Agreement shall commence at midnight on June 1, 2006, and shall terminate at 11:59 p.m. on May 31, 2009. The first extended term of this Agreement shall commence at midnight on June 1, 2009, and shall terminate at 11:59 p.m. on May 31, 2010. The second extended term of this Agreement shall commence at midnight on June 1, 2010, and shall terminate at 11:59 p.m. on May 31, 2011, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner."

2. Except as expressly amended herein, all of the terms and conditions in Agreement No. 29704 are ratified and confirmed and shall remain in full force and effect.
