SEVENTH AMENDMENT TO AGREEMENT NO. 33580

THIS SEVENTH AMENDMENT TO AGREEMENT NO. 33580 is made and entered, in duplicate, as of August 8, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 16, 2019, by and between SIMPLER SYSTEMS, INC., a California corporation ("Consultant"), with a place of business at 1233 B State Street, Santa Barbara, California 93101, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33580 (the "Agreement") whereby Consultant agreed to provide services in connection with maintenance of the City's Financial Accounting Information System; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to September 30, 2017 and add the authorized annual amount of \$150,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to September 18, 2018 and add the authorized annual amount of \$150,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to September 30, 2020, add the authorized annual amount of \$150,000, and update the City's Notice address; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to September 30, 2021 and add the authorized annual amount of \$150,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term to September 30, 2022 and add the authorized annual amount of \$150,000; and

WHEREAS, the Parties entered into a Sixth Amendment to extend the term to September 30, 2023 and add the authorized annual amount of \$150,000; and

1 WHEREAS, the Parties desire to extend the term one (1) additional one-
2 year period and add the authorized annual amount of \$150,000;

3 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
4 conditions herein contained, the Parties agree as follows:

5 1. Section 1.A. of the Agreement is hereby amended to read as follows:

6 “A. Consultant shall furnish specialized services more particularly
7 described in Exhibit “A”, attached to the Agreement and incorporated by this reference, in
8 accordance with the standards of the profession, and City shall pay for these services in
9 the manner described below, in a total amount not to exceed One Million Five Hundred
10 Thousand Dollars (\$1,500,000) at the rates or charges shown in Exhibit “A”.”

11 2. Section 2 of the Agreement is hereby amended to read as follows:

12 “2. TERM. The term of this Agreement shall commence on October 1,
13 2014, and shall terminate on September 30, 2024, unless terminated earlier, as provided
14 in this Agreement.”

15 3. Except as expressly modified herein, all of the terms and conditions
16 contained in Agreement No. 33580 are ratified and confirmed and shall remain in full
17 force and effect.
