

AMENDMENT NO. TWO TO CONTRACT NO. 36039

RE: Amendment Two of ITB FS 21-077, Contract No. 36039 for the purchase of Cummins & Detroit Engine Parts and Repair Services for the City of Long Beach (Munis Contract 32101124)

This Amendment to Contract No. 36039 is made and entered as of June 14, 2023, by and between the CITY OF LONG BEACH, a municipal corporation, and Performance Truck Repair Inc.

Contract No. 36039 is amended by mutual agreement of the parties and as indicated below by a check or other mark preceding the appropriate amendment:

- 1. The term is extended to September 30, 2024
- 2. \$25,000 has been added to the 1st renewal term for a total contract amount for all years of the Agreement not to exceed \$200,000 in the aggregate.
- 3. Prices during this period shall remain firm.
- 4. The price for this Agreement shall be amended and replaced by the rates and charges as shown in Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 5. The pricing this Agreement shall be amended to include the rates and charges as shown on Exhibit "A", which is attached hereto and incorporated herein by this reference.
- 6. The discount offered to the City is increased by ___ %
- 7. The items or locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby deleted from the Contract.
- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.
- 9. Current permits, licenses, insurance, and other required information are attached as Addendum No. 1.

Except as expressly amended above, all terms and conditions in this Contract are ratified and confirmed and remain in full force and effect. Executed with all formalities required by law as of the date first stated above.
